EXCLUSION OF STUDENT CASE #0110

Director Low stated after the Board's consideration of the evidence presented in the matter of the recommendation to exclude Student Case #0110, the Board adopts the findings of fact set out in the Administrative Advisory Council, and the Board concludes the student violated the regulations and rules established by the Board and the continued presence of the pupil is detrimental to the best interest of the school:

MOTION: Director Low moved that after the Board's consideration of the evidence presented in the matter of the recommendation to exclude Student Case #0110:

- 1) that Student Case #0110 be excluded from the Davenport Community School District for the remainder of the 2001-02 school year;
- 2) that Student Case #0110 will receive alternative services at the Harrison Street program for the remainder of the 2001-02 school year;
- 3) that Student Case #0110 will not be allowed on any Davenport Community School District property or be in attendance at any school event where a Davenport team is participating during the time of the exclusion other than the site of his alternative programming;
- 4) that prior to the beginning of the 2002-2003 school year, a re-entry hearing will be scheduled to determine appropriate placement for Student Case #0110.

Director Zamora seconded the motion.

The vote on the motion was called and recorded as follows: Ayes: Low, Clewell, and Imming. Abstaining: Zamora. Motion carried.
